**Subject:** Request for early disposal of the representations on issuing of UP Govt order for the eligible De-Notified tribes living in Uttar Pradesh-Reg


**Ref:** The grievance letters from Dr. B.K. lodhi ( dated 21.05.2020) and Various representations of Shri Mohit Tanwar Greater Noida -201310

Sir,

With reference to above refereed subject matter, Please find enclosed the grievance letters from Dr. B.K. lodhi (dated 21.05.2020) in which he has informed that the De-notified tribes in UP are bereft of their main "De-notified tribe" identity and related constitutional rights. Dr. Lodhi has raised following points that need a due consideration by UP government:

- 2) He has further claimed that the de-notified tribes which are included in Schedule case they are not being issued the De-notified caste certificates to maintain their exclusive identity.
- 3) The de-notified tribes which are included in OBC and general category are being issues "de-notified caste (vimukt jati) " certificates only in a few districts .
- 4) The National Commission on De-notified, Nomadic and Semi-Nomadic tribes (Idate Commission Report 2018) has issued the state wise list of De-notified tribes in which based on acceptance given by the State Government of UP a confirmed list 1A gives the de-notified tribes of UP ( copy of the Idate Commission report is enclosed).
- 5) The non-issue of vimukt jati certificates not only hampers these community developments, but it also denies admission, scholarships etc to the student from these communities.
- 6) As the De-notified tribes which are also OBC are issued two set of caste certificates –one of OBC and another for being "vimukt jati", similarly De-notified tribes which are SC should be considered to issue two set of caste certificates –one of SC and another for being "vimukt jati".

Therefore it is requested that the matter may please be considered urgently for early disposal of the representations on issuing of UP Govt order for the eligible De-Notified tribes living in Uttar Pradesh. The attachments are sent by email.
